

Hate in the Pandemic Inquiry

Consent Form - Community Organizations

BC's Office of the Human Rights Commissioner (BCOHRC) is conducting an inquiry into hate in the COVID-19 pandemic (Inquiry). BCOHRC believes that hearing directly from community organizations is critical to understanding communities' experiences with hate during the pandemic.

Community organizations can participate in the Inquiry by making an online oral presentation or participating in a roundtable and/or by providing a written or video submission. The Commissioner will rely on these presentations and submissions to inform the final Inquiry report and recommendations and will identify the presentations and submissions she relies on in her final report and on the Inquiry website.

In order to capture what organizations present to the Commissioner, BCOHRC will record organizations' oral and roundtable presentations. BCOHRC is asking if organizations consent to BCOHRC:

- posting audio recordings of oral or roundtable presentations on the <u>Inquiry</u> <u>website</u>
- posting written and/or video submissions on the Inquiry website
- attributing quotes to participants from oral presentations and submissions in the Inquiry final report and promotional materials.

Consent is completely voluntary. It is your choice.

If you would prefer that BCOHRC keep your organization's presentation and/or submission confidential, you can choose not to provide consent. Community organizations can make an oral or roundtable presentation to the Commissioner "in camera," meaning that the session will not be posted on the Inquiry website. Community organizations can also provide a written or video submission to the Commissioner confidentially, meaning that it will not be posted to the Inquiry website. Only people authorized by the Commissioner, which will be limited to staff or contractors of the BCOHRC, will have access to confidential presentations and submissions.

You may revoke your consent at any time by writing to BCOHRC at inquiry@bchumanright.ca and withdrawing your consent. However, BCOHRC cannot be responsible for any information already publicly disclosed prior to consent being revoked. BCOHRC will retain the information it receives during the Inquiry in accordance with BCOHRC's retention policies.
